

TOWN OF HARDISTY
BY-LAW NO. 1126/08

PROVINCE OF ALBERTA

A BYLAW OF THE TOWN OF HARDISTY BEING ENACTED FOR THE PURPOSE OF CLOSING TO PUBLIC TRAVEL, A LANEWAY LOCATED ON BLOCK 18 SEPERATING LOTS 20 AND 22 AND LOTS 23 AND 1A

WHEREAS Section 18 of the *Municipal Government Act*, R.S.A. 2000, c.M-26, as amended provides that a municipality has the direction, control and management of all roads within the municipality;

WHEREAS Section 22 of the *Municipal Government Act*, R.S.A. 2000, c.M-26, as amended provides that no road in a municipality that is subject to the direction, control and management of the municipality may be closed except by bylaw;

WHEREAS the Municipal Council of the Town of Hardisty, in the Province of Alberta, has given notice to persons registered or assessed as owners of the land abutting upon the portion of the Road in the manner and form prescribed by Section 22 of the *Municipal Government Act*, Chapter M-26, RSA 2000, of its intention to pass a bylaw for the purpose of closing a laneway described as:

Firstly: Plan 2242KS, Block 18

All that portion of Lane and adjoining Corner Cut-off lying South East of the production South Westerly of the North West boundary of Lot 1A, Block 18, Plan 2239NY and lying North West of the production South Westerly of the South East boundary of said Lot.

Secondly: Plan 2242KS, Block 18

All that portion of Lane and adjoining Corner Cut-off lying South East of the production South Westerly of the North West boundary of Lot 20, Block 18, Plan 2242KS and lying North West of the production South Westerly of the South East boundary of said Lot.


Excepting thereout all mines and minerals.

WHEREAS the said Council of the Town of Hardisty held a Public Meeting on March 26th, 2008 at which any person who claimed his property would be affected prejudicially by the said road closure was given an opportunity to be heard by Town Council.

NOW THEREFORE BE IT RESOLVED that the Council of the Town of Hardisty in the Province of Alberta, duly assembled, enacts as follows:

1. Subject to clause 2 of this Bylaw, the Town of Hardisty does hereby close the Road, subject to rights of access granted by other legislation or regulations;
2. The proposed closure of the Road shall be subject to the approval of the Minister of Infrastructure and Transportation as provided for under the *Municipal Government Act*, R.S.A. 2000, c. M-26, as amended.
3. This Bylaw shall have no force or effect unless such approval has been obtained.

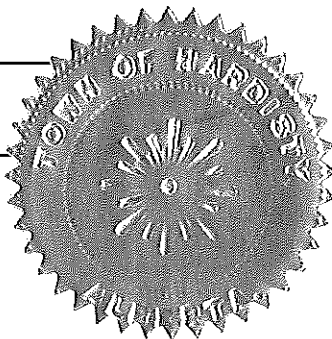



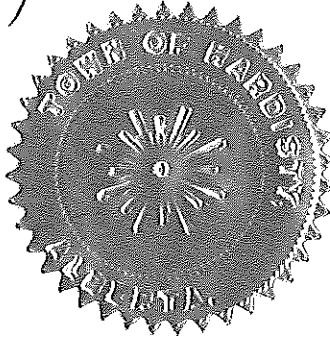
